For California Borrowers, the Share Secured Visa Classic is a secured credit card. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings.

Fly Miles Plus® Rewards - Visa Platinum (Variable), Share Secured Visa Classic (Fixed):

\$35.00 annually. This program fee is charged to all accounts that elect to have SDCCU's Fly Miles Plus® Rewards Program. This fee is waived if annual purchases are \$6,000.00 or more. The Fly Miles Plus® Rewards Program is not available on the Visa Signature (Variable).

Late Payment Fee:

\$10.00 or the amount of the required minimum payment, whichever is less, if you are 11 or more days late in making a payment.

Returned Payment Fee:

\$20.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$5.00.

Statement Copy Fee:

\$5.00 per document.

Non-CO-OP ATM Withdrawal Fee:

\$3.00 each.
