SWEEPSTAKES PERIODS. School nominations for the SDCCU Classroom Heroes Summer Kick Off Concert (SKOC) Artist Private Concert Sweepstakes (the “**Sweepstakes**”) begin on 3/30/2015 at 6:00 a.m. Pacific Time (“**PT**”) and end on 4/12/2015 at 11:59 p.m. PT (“**Nomination Period**”). The voting period will begin on 4/13/2015 at 1:00 p.m. PT and ends at 4/26/2015 at 11:59 p.m. PT (“**Voting Period**”) and together with the Nomination Period, the “**Sweepstakes Period**”). Entries received prior to or after the Nomination Period are not eligible for the Sweepstakes. Entry in the Sweepstakes does not constitute entry into any other promotion, contest, or sweepstakes.

ELIGIBILITY. Any legal U.S. resident of the fifty (50) United States and the District of Columbia, excluding New York and Florida, who is eighteen (18) years old or older as of time of entry can nominate any San Diego County high school serving grades 9-12 (“**School**”) for entry in the Sweepstakes. submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible. AGREEMENT TO OFFICIAL RULES. Participation in the Sweepstakes constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of SDCCU, which are final and binding in all matters relating to this Sweepstakes.

VOTING; WINNER SELECTION. For each eligible, nominated School, Sponsor will create a post on the Website ("Voting Post"). To vote for a School, either like the School's Voting Post or post a comment to the Voting Post during the Voting Period. Each comment and each like counts as one (1) vote (a "Vote"). Limit one (1) Vote per person per day. The School with the highest number of eligible Votes on its Voting Post, during the Voting Period, will win the Grand Prize. The winning School will be announced on or about 5/4/2015. Determination of winning School is in Sponsor's sole discretion. Any totals of Votes listed on the Website are unofficial.

PRIZE; ODDS. The Grand Prize for the one (1) winning School is \$1,000 and a private concert by a SKOC artist at the winning School on 5/8/2015 (Approximate Retail Value (ARV): \$11,000). Prize must be approved by the winning School. The whole prize must be accepted in order to claim the Grand Prize. The odds of winning depend on the number of eligible Schools nominated during the Nomination Period. Sponsor cannot accurately predict the number of Schools who will participate in the Sweepstakes.

PRIZE NOTIFICATION. The potential winning School will be notified via phone, using the publically listed telephone number. SDCCU will make reasonable efforts to contact the winning School. If any potential winning School does not respond to prize notification attempts within two (2) days of the first notification attempt (or such shorter time as exigencies may require), is found to be ineligible, or if the School has not complied with these Official Rules or declines the prize for any reason prior to award, such potential winning School will be disqualified and an alternate School may be selected. Sponsor may successively attempt to contact up to two (2) potential winning Schools in accordance with such procedure, and if there is still no confirmed prize winner after such attempts have been made, if any, the applicable prize may go unawarded.

ARBITRATION PROVISION: By participating in this Sweepstakes, each entrant agrees: (i) that any and all disputes the entrant may have with, or claims entrant may have against, the Sweepstakes Entities relating to, arising out of or connected in any way with (a) the Sweepstakes, (b) the awarding or redemption of any prize, and/or (c) the determination of the scope or applicability of this agreement to arbitrate, will be resolved exclusively by final and binding arbitration administered by JAMS and conducted before a sole arbitrator in accordance with the rules of JAMS; (ii) this arbitration agreement is made pursuant to a transaction involving interstate commerce, and shall be governed by the Federal Arbitration Act ("FAA"), 9 U.S.C. §§ 1-16; (iii) the arbitration shall be held in San Diego County, California; (iv) the arbitrator's decision shall be controlled by the terms and conditions of these Official Rules and any of the other agreements referenced herein that the applicable entrant may have entered into in connection with the Sweepstakes; (v) the arbitrator shall apply California law consistent with the FAA and applicable statutes of limitations, and shall honor claims of privilege recognized at law; (vi) there shall be no authority for any claims to be arbitrated on a class or representative basis, arbitration can decide only entrant's and/or Sponsor's individual claims; the arbitrator may not consolidate or join the claims of other persons or parties who may be similarly situated; (vii) the arbitrator shall not have the power to award punitive damages against the entrant or Sponsor; (viii) in the event that the administrative fees and deposits that must be paid to initiate arbitration against Sponsor exceed \$125 USD, and entrant is unable (or not required under the rules of JAMS) to pay any fees and deposits that exceed this amount, Sponsor agrees to pay them and/or forward them on entrant's behalf, subject to ultimate allocation by the arbitrator; (ix) if the entrant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of entrant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (x) with the exception of subpart (vi) above, if any part of this arbitration provision is deemed to be invalid, unenforceable or illegal, or otherwise conflicts with the rules of JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, subpart (vi) is found to be invalid, unenforceable or illegal, then the entirety of this arbitration provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute.
