**SPONSOR.** San Diego County Credit Union® (“SDCCU®” or “Sponsor”), PO Box 261209, San Diego, CA 92196-1209.

**SWEEPSTAKES PERIOD.** The Hillcrest Branch Grand Opening 2015 Sweepstakes (the “Sweepstakes”) begins on 6/4/2015 at 9:00 a.m. Pacific Time (“PT”) and ends on 6/30/2015 at 5:00 p.m. PT. One (1) grand prize will be randomly selected from among all eligible entries received at each branch, on or about 7/2/2015 at 5:00 p.m. PT (“Winner Selection Date”).

**HOW TO ENTER.** Visit the Hillcrest Branch located at 502 University Avenue, Suite 500, San Diego, CA 92103 during the sweepstakes period and fill out an entry form. Entries are limited to one (1) per person. The odds of winning depend on the total number of eligible entries received.

**ALTERNATE ENTRY.** Eligible entrants (as described below) may also enter the Sweepstakes by hand printing the words “Hillcrest Branch Grand Opening 2015 Sweepstakes” and your full name, address, daytime phone number (including area code), email address (if any) and date on a 3x5 card and mailing it to (one (1) postcard per envelope): San Diego County Credit Union, Hillcrest Branch Grand Opening 2015 Sweepstakes, Attn: Marketing Dept., PO Box 261209, San Diego, CA 92196-1209. SDCCU is not responsible for, and will not accept, lost, late, incomplete, misdirected, delayed, damaged, destroyed, deleted, erased, stolen, postage-due or illegible entries or mail. SDCCU will not verify receipt of entries for entrants. Mechanically reproduced entries will not be accepted. Once submitted, all entries become the property of SDCCU and none will be returned. SDCCU assumes no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. SDCCU will make its best reasonable effort to contact winners. If the potential prize winner does not respond to prize notification attempts within five (5) days of the first attempt, is found to be ineligible, or if he or she has not complied with these Official Rules or declines the applicable prize for any reason prior to award, such potential prize winner will be disqualified and an alternate winner may be selected.
