SPONSOR. San Diego County Credit Union® (“SDCCU®” or “Sponsor”), PO Box 261209, San Diego, CA 92196-1209.

SWEEPSTAKES PERIOD. The North Park and Sports Arena Grand Opening 2014 Sweepstakes (the “Sweepstakes”) begins on 1/17/2014 at 9:00 a.m. Pacific Time (“PT”) and ends on 2/28/2014 at 6:00 p.m. PT. One (1) grand prize will be randomly selected from among all eligible entries received at each branch, on or about 3/4/2014 at 5:00 p.m. PT (“Winner Selection Date”).

HOW TO ENTER. Visit the North Park Branch located at 3180 University Avenue, Suite 100, San Diego, CA 92104 or the Sports Arena Branch located at 3455 Sports Arena Boulevard, Suite 120, San Diego, CA 92110 during the sweepstakes period and fill out an entry form. Entries are limited to one (1) per person. The odds of winning depend on the total number of eligible entries received.

ALTERNATE ENTRY. SDCCU is not responsible for, and will not accept, lost, late, incomplete, misdirected, delayed, damaged, destroyed, deleted, erased, stolen, postage-due or illegible entries or mail. SDCCU will not verify receipt of entries for entrants. Mechanically reproduced entries will not be accepted. Once submitted, all entries become the property of SDCCU and none will be returned. SDCCU assumes no responsibility for any error, problem, or malfunction (human, technical, or otherwise) which may occur in the creation, maintenance or processing of Sweepstakes entries, or which prevents entries from being created. SDCCU will make its best reasonable effort to contact winners. If the potential prize winner does not respond to prize notification attempts within five (5) days of the first attempt, is found to be ineligible, or if he or she has not complied with these Official Rules or declines the applicable prize for any reason prior to award, such potential prize winner will be disqualified and an alternate winner may be selected. Sponsor may successively attempt to contact up to two (2) potential prize winners in accordance with such procedure, and if there is still no confirmed prize winner after such attempts have been made, if any, the applicable prize may go unawarded.
