**SPONSOR.** San Diego County Credit Union® (“SDCCU®” or “Sponsor”), PO Box 261209, San Diego, CA 92196-1209.

**SWEEPSTAKES PERIOD.** The Sorrento Mesa Branch Grand Opening 2015 Sweepstakes (the “Sweepstakes”) begins on 6/9/2015 at 9:00 a.m. Pacific Time (“PT”) and ends on 6/30/2015 at 5:00 p.m. PT. One (1) grand prize will be randomly selected from among all eligible entries received at each branch, on or about 7/2/2015 at 5:00 p.m. PT (“Winner Selection Date”).

**HOW TO ENTER.** Visit the Sorrento Mesa Branch located at 10066 Pacific Heights Boulevard, Suite 104, San Diego, CA 92121 during the sweepstakes period and fill out an entry form. Entries are limited to one (1) per person. The odds of winning depend on the total number of eligible entries received.

If the potential prize winner does not respond to prize notification attempts within five (5) days of the first attempt, is found to be ineligible, or if he or she has not complied with these Official Rules or declines the applicable prize for any reason prior to award, such potential prize winner will be disqualified and an alternate winner may be selected.
